Context:

Many students with Special Education Needs (SEN) today lack workplace exposure and often face difficulties securing internship opportunities.

This mentorship program aims to address these challenges by providing SEN students with first-hand experience and guidance from experienced professionals.

All mentors have a minimum 2-3 years of professional experience in the relevant industry/ field.



About the Program

As a mentee, you will engage in 4 x one-to-one mentoring sessions that will centre around a discussion of your career goals. This is an opportunity to review practical skills for job application process. You can also discuss about your previous experiences, your skillset, professional plans, and your career and education pathways.

Other activities may include:

- Reviewing your resume and cover letters
- Practicing mock interviews
- Visiting worksites
- Networking with other professionals
- Discussing workplace accommodations and adjustments
- Building your confidence

What are you committing to?

- Attending 4 x one-on-one mentoring sessions over 4 months (online or in your mentor's offices)
- 60 minutes per session
- Flexible scheduling in mutual agreement between you and your mentor

About you

To participate, you must be between 18 -23 years old and have special education needs. Currently studying towards an Associate's, Higher Diploma, or Bachelor's Degree.
